

RECORD OF PROCEEDINGS
TRUSTEES OF FRANKLIN TOWNSHIP
THURSDAY OCTOBER 16, 2025

The Trustees of Franklin Township met in regular session on Thursday October 16, 2025 at 7:00 P.M. at Franklin Township Hall. Trustees present: Chad Bonifant, Dan Donato and Brent Metzger. Also present: Tom Spidell, Fire Chief Jason Ely, Jeremy Bleininger and Phil Reifenschneider. The minutes from the September 11, 2025 meeting were read and approved. The checks 1243-1257 were approved.

The Fiscal Officer presented The Fund Status, Cash Journal, Appropriation Summary, Revenue Summary, Fund Summary, Payment Report, Bank Statement and Bank Reconciliation for review.

Tom Spidell reported that they have finished berming. Central is now ready for paving. Newtons Asphalt should be paving in next couple of weeks.

Tom Spidell reported a complaint from Dale Miller. No one obeys the stop signs at the bottom of Mt Healthy. Not much Township can do about it. The County is patrolled by two sheriffs. They can't be everywhere in the County.

Brent made a motion to accept the amounts and rates presented by the County for the year 2026. Dan seconded motion. All trustees voted yes to pass resolution 2025-7.
